Le travail hebdomadaire dans la structure d'accueil de l'étudiant-alternant doit être égal à celui indiqué sur son contrat. Les droits aux congés sont identiques à ceux des salariés de droit commun. Ils dépendent du Droit du Travail, de la convention collective ou des règles propres à la structure d'accueil. Pour préparer ses examens, l'apprenti a droit à un congé supplémentaire de cinq jours ouvrables (cf article du code du travail L6222-35). Ce congé, qui donne droit au maintien du salaire, est situé dans le mois qui précède les épreuves. Le contrat de professionnalisation prévoit également ces 5 jours pour révision mais non rémunérés sauf en cas de disposition conventionnelle. Lorsque l'étudiant-alternant n'est pas en cours, il doit être en entreprise durant la période de son contrat.
